Latest FIDE rules will be followed. Number of rounds 8. Time control 90 minutes + 30 seconds increment. Protests if any must be lodged within 15 minutes of the incident with protest fee Rs.500/-. Higher prize can be opted by the player. AICF registration is compulsory. CAK registration for Kerala Players & CAE registration for Ernakulam players is a must. CUSAT is at South Kalamassery Ernakulam Dist. Kerala. 10 KM. from Aluva Railway station & 12 KM. from Ernakulam Railway station. Entry closes at 8.00 pm on 18-12-2016. Proof of D.O.B. is a must for claiming category prizes.
