Rules and Regulations

- AICF registration for the year 2022- 2023 is mandatory.
 It should be done well before the start of the championship.
- 2. Four players from every affiliated District Association of CAK.
- 3. All former state champions can participate as seeded player (ordinary entry)
- 4. Any other player who remits the prescribed special entry fee of Rs.1900/-
- Entry/Entries: All entries including special entries should come through the concerned Affiliated District Association. All participants should be a registered player of the concerned affiliated District Association
- Entry Fee structure: Ordinary Entry: 1300/- Special Entry: Rs. 1,900/No spot registration. Last date to register with normal fee structure is 25th of September
 2022 and last date to register with a late fee of Rs. 150/- is 27th of September 2022
 before 5pm.
- System of Play: The championship will be played under FIDE's Laws of Chess and the Swiss System
- 8. Default Time: 15 minutes
- 9. Time Control: 90 Minutes each with 30 Seconds Increment from move number one
- 10. Tie Break:

Following is the order of Tie Break

- 1) Buchholz Cut 1.
- 2) Buchholz.
- 3) Sonneborn Berger.
- 4) Direct encounter
- 5) The greater number of wins (forfeit included)
- 6) Number of wins with Black pieces
- In case of tie, prizes will not be shared.
- 11. Protest: Protest, if any against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.500/- within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld.
- 12. Tournament Committee: The organizers will form a tournament committee for the smooth conduct of the Championship.

- 13. Interpretation: For interpretation of the rule(s) and deciding any point not covered by the above rules of the tournament, the decision of the Tournament Committee shall be final and binding on all. The tournament committee has every right to make any addition or amendment to these rules, without prior notice. However, such changes/ or inclusion will be subject to CAK clearance. Such changes will, however, be displayed in the tournament hall.
- 14. Withdrawal: A Player may withdraw at any stage of the event only after informing the Chief Arbiter in writing.

Electronic Devices

In addition to the usual regulations for mobile phones and electronic devices, players are forbidden to wear any kind of wristwatch. Players wearing watches will be declared lost.
